Healthcare multi-employer training: to provide ESL (English as a Second Language) and computer classes on-site in area hospitals for represented EVS (environmental service) and Food Service workers. Classes are provided on-site to reduce barriers to participation for students.

4c (Code:) (Expenses \$ 36,938 including grants of \$) (Revenue \$)

Vocational basic skills: small group instruction for adults on Temporary Assistance to Needy Families (TANF). The goal of instruction is to build reading, writing, English and math skills to the point where learners can enter specific vocational trainings focused on skills which will get them living wage jobs. Staff members work with the Washington State Department of Social and Health Services, vocational technical colleges and the Washington State Employment Security Department to coordinate wrap-around services.
