Our students face great challenges and strive for success against tremendous odds, but all share one common element--the desire to learn, to achieve and to live a better life.

City/County funded services: In addition to offering classes at our main Learning Center in Lake City, we partner with local governments to provide English language instruction at various offsite locations, including:

*Citizenship: Literacy Source partners with the City of Seattle to provide classes and services to help low-income City of Seattle residents become United States citizens. (Continued at Schedule O)
